



Submitting Samples Online

This guide covers how to use the online sample submission form.

Overview

This feature allows the lab customer to fill out a sample submission form online. The external user may create a new sample submittal form by entering all information, by copying from a previous submittal. They can also create a form using an existing Lot Number that they have previously sent to the lab. If you use Pure Harvest for field inspection, the user can create a sample from their existing field number.

The information entered by the customer is printed on a paper document which the customer sends in with his sample. The sample is assigned a temporary number starting in XT (for external). When the lab receives the physical sample accompanying the form, the lab entry person just enters the XT number and all the information provided by the customer is imported to Pure Harvest. The lab entry person reviews it for correctness and then saves it. After the data is retrieved and saved, the external user can no longer change it.

Setup

When submitting a sample, your customers can check off the requested Tests & Services for the sample.

The list of tests and services they can choose from is controlled by the Test Groups called **XT Tests** and **XT Services** Use the Seed Lab → Tests In Groups page to add or remove tests & services from these lists.

Navigation

The Online Submission form can be accessed by your customers from the track interface

Accepting The Sample

When you receive the sample, on the New Sample page you can look-up enter the XT # and the details will be automatically filled in. This makes it quicker and easier to enter new samples, and also greatly reduces the possibility of data entry errors by removing the need to decipher handwriting and possible spelling errors.

From the Seed Lab → XT Samples screen, You can see what samples are coming in that have not yet been received.



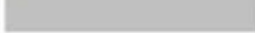

The label, as shown, should be included with the physical sample when it comes to your lab.
